## PRODUCT DESCRIPTION

Deep cleaner is an effective high-performance cleaner, helping to remove stubborn greasy stains and heavy soiling. This powerful cleaner has excellent degreasing properties and can be used on all areas externally on any type of natural stone including sandstone, limestone, granite, slate, terracotta, brickwork, porcelain, ceramic and all types of concrete. This easy to use versatile product can also be used internally on porcelain and ceramic tiles where a normal strength cleaner is not enough. Formulated with biodegradable components and degreasing agents, giving you fast and long-lasting results.

## APPLICATION

Always test a small inconspicuous area before proceeding to ensure the finished result is satisfactory.

Shake the container well before use.

Dilute by adding the following ratios of Deep Cleaner to water.

**For Extremely Heavy Soiling** - Use neat and apply using a low-pressure pump sprayer or watering can, agitate with a stiff brush. Allow to act for 10-15 minutes, agitate with a stiff brush again and whilst the surface is still wet, thoroughly rinse, ensuring all residue is removed. For optimum results use warm water.

**For Heavy Soiling** - Use 1 part Deep Cleaner to 3 parts water and apply using a low-pressure pump sprayer or watering can, agitate with a stiff brush. Allow to act for 5-10 minutes, agitate with a stiff brush again and whilst the surface is still wet, thoroughly rinse, ensuring all residue is removed. For optimum results use warm water.

**For General soiling** - Use 1 part Deep Cleaner to 10 parts water and apply using a low-pressure pump sprayer or watering can, agitate with a stiff brush. Allow to act for 5-10 minutes, agitate with a stiff brush again and whilst the surface is still wet, thoroughly rinse, ensuring all residue is removed. For optimum results use warm water.

**On larger areas** mechanical scrubbers can also be used.

**Machine application interior and exterior: (scrubber driers).**

Use the same ratio as above depending on cleaning requirement and set the release rate as normal, scrub and extract.

## STORAGE INFORMATION

Once opened use within 6 months.

Shelf life up to 5 years if stored in the original unopened container in a clean, dry area at 5°C - 25°C (41°F - 77°F)

## RECOMMENDATIONS

Cleaned patios that have been previously sealed should be re-sealed after using this product. This should be done after rinsing with plenty of clean water and once surfaces have had sufficient time to thoroughly dry (min 24hrs). Do not apply if rain is expected, when its frosty, or when the surface is <5°C and >25°C (<41°F and >77°F). Please be aware darker colours will have a considerably higher surface temperature in warmer weather conditions. Do not mix with any other product.

Empty containers are recyclable.

Please dispose of packaging and waste products in line with current environmental legislation.
